

## **USE OF VILLAGE/ARTHUR-LUGIBIHL COMMUNITY CENTER EXERCISE ROOM AND RELEASE POLICY**

The Village of Pandora, Ohio/Arthur-Lugibihl Community Center (“Village/ALCC”) grants the use of the Village/ALCC exercise room to resident of the Village and guests of the Village residents for occasional use which the Village considers advisable as a community service, and at which times the Village may allow for such use. During such times as the Village may open the Village/ALCC exercise room for public use, the activities within the facility are not under the direct or indirect supervision of the Village/ALCC, its officers, council members, board members or employees. Any officer, council members, board members or employee of the Village or PG Schools who may be on the premises or participating activities is not in the capacity of officer, council members, board members or employees during such time and is not responsible for supervision. All persons using the Village/ALCC exercise room are responsible for providing their own supervision during such activities.

Persons using the Village/ALCC exercise room during such times as it may be available to the public shall be responsible for any and all damages that may be caused by reason of the use or occupancy, and the Village/ALCC, PG Schools and its officers and employees shall not be liable for any suit for damages which might arise as the result of such use or occupancy.

All persons requesting to use the Village/ALCC exercise room shall sign a copy of this policy and release before participating in any activity at the Village/ALCC exercise room during the time said facility is made available to the public. A parent or legal guardian shall sign the form on behalf of any child under the age of 18 who will be using the facility during the time the facility is made available to the public, and the parent/guardian (not the Village/ALCC or Village employees or PG Schools) shall be responsible for the supervision of his/her child(ren) during such times as the child(ren) may be using the facility.

Included in the activities which are available to the public under the policy is weight training. All persons who shall be using the weight training equipment shall either have received instruction in the proper use of the equipment (at user’s cost) or shall sign a waiver indicating such training is not desired. The Village/ALCC, PG School is not responsible for the training in the proper use of the equipment during the time the facility is open to the public.

The Village Mayor/Village Administrator/Village Council Members/Board Members may prohibit the use of the Village/ALCC exercise room by any person(s) for legitimate reasons, including but not limited to fighting, threatening to fight, disrespect show toward other people, and damaging the facility

Public Hours: 7am to 11pm. Membership fee 1<sup>st</sup> year: \$40 single/\$80 family  
- Renewal fee: \$100 single/ \$130 family

- PG Sports programs will have first opportunity for use of exercise room for their regular scheduled programs.

*ALL USERS OF THE FACILITY, PRIOR TO USE, MUST READ AND SIGN THE FOLLOWING (PARENTS/GUARDIANS SHALL READ AND SIGN ON BEHALF OF CHILDREN UNDER AGE 18). I have read the above policy and wish to have access to the Village/ALCC exercise room for recreational use. I understand that the Village/ALCC will not be providing supervision during such time as the facility is open for public use. I understand that I am responsible for all damage caused by me during the use of the facility and that neither the Village/ALCC, PG Schools and its officers and employees shall be liable for any suit for damages arising out of such use and I hereby waive any and all rights I may have to seek damages from the Village/ALCC, PG Schools and its officers and employees arising out of my use of the Village/ALCC exercise room during such times as the Village/ALCC make the facility open for public use.*
